Include in this request to evaluate air pollution in Sun Valley, conduct health impacts and air quality survey in Sun Valley, review existing permits of AMH Recycling and all polluting businesses surrounding Sun Valley Park Area, enforce all environmental regulations, add Sun Valley to MATES VI program and zero emissions infrastructure projects, gather complete air pollution data on Sun Valley Community, prevent future increase in cumulative environmental impacts in Sun Valley. Present supporting reports and research.

**ITEM 7: Motion/Discussion/Possible Action:** send a letter to Councilwoman Padilla to initiate contact, request that Los Angeles County Public Works flattens the grounds of future Rory Shaw Wetlands Park to help reduce air pollution and cumulative health and environmental impacts on the surrounding residential community, including schools, recreation center; apply hydro mulching at least twice a year to maintain the grounds and reduce source of dust and methane traces from this 46 acre former inert landfill, regularly provide updates to public on different phases of project implementation, regularly clean up around the lot, monitor Tujunga Ave for trash, RVs, fire hazard tires, vehicle carcasses left in a public street.
