ITEM 1: Monica Vacas called the meeting to Order at 6:33 pm. The Pledge of Allegiance was recited. Rollcall was taken by Norma O. Chávez and quorum was established with thirteen members present. The Code of Civility was recited.

ITEM 2: President, Monica Vacas, welcomed the new Board.

ITEM 3: EMERGENCY Personnel from Fire and Police departments No member from the Emergency Personnel was able to attend the meeting.

ITEM 4: Announcements from elected officials or their representatives

A. Karla Maqueda (CD6, field deputy from Council President Nury Martinez)

- Sanitation is back to their old place. They are currently hiring. There were 40 vacant opportunities.
- Measure 41.18 passed, but needs to go to a second voting process because the vote was not unanimous. This process will take place in about 30 days. Measure 41.18 prohibits homeless encampments within 500 feet from schools, parks, libraries, day cares, railroads, freeways, new shelters, and any other places that might create a public safety hazard.
- There are two Preferential Parking Districts coming in August 9. One will be in Sun Valley and the second will be in North Hollywood by LAHousing.
- She will bring back information on the work being done on the railroad trails on San Fernando Road and Sheldon Street. No information at this moment.

B. Tiffany Zeytounian (CD2, field deputy from Council member Paul Krekorian, (818) 755-7676, tiffany.zeytounian@lacity.org)

- NoHo Summer Night – a series of FREE concerts from August 21 to September 11 at the North Hollywood Park with food trucks available starting at 6:30 pm and the concerts beginning at 7:00 pm.

C. Lea Gonzalez (field deputy from the office of Congressman Tony Cardenas)

- Starting on July 15, the child tax credit will start. There are about 156,000 kids in this district that are eligible and whose parents could benefit from the tax credit. There will be \$300 for children between the ages of 0-5 years old and \$250 for those ages 6-17. Contact their office for more information.
- 19.1 million dollars were approved to Invest in the America Act for road and transit improvement. 594,000 specifically for Sun Valley for the San Fernando Road bike path that starts on Branford St. and runs all the way to Cohasset
- We are back in the office so contact us if you want any more details

D. Art Garcia (district director from the office of Assemblywoman Luz Rivas)

- The new field deputy assigned to Sun Valley is Julissa Hernandez. She provided the report from the office of Assemblywoman Luz Rivas.
- Legislation update: AB 585 bill for extreme heat and community resilience program. The legislation passed this afternoon.
- Northbound of 170 freeway at Roscoe, Caltrans will be removing a dead tree. Northbound of the 5 freeway on Osborne and Roxford, Caltrans will be performing a sweep off on the left and right sides of the ramp. The Southbound of the 5 freeway from Sylmar to Sun Valley, Caltrans will perform a sweep the left and right of the ramps. Northbound of the 5 freeway from Sylmar to Sun Valley, Caltrans will be sweeping the right shoulder. Thanked everyone who contacted the office to get this resolved.
- District 39 was given 2,873,000 dollars for free standing
- Caltrans Job Fair on July 20 from 10:00 am to 2:00 pm.
