ITEM 8: Committee Reports— Outreach, Disaster Preparedness, Beautification, LANCC, Planning, Plancheck, Homeless, Budget Advocates, and Election Committee

- Outreach: Ms. Vacas announced her Homeless Count sign-up sheet for those interested, and that there would be a meeting on this subject soon.
- Disaster Preparedness: Mr. Khalaf stepped out and was unavailable for comment. Beautification: Ms. Thum announced the upcoming plan to have a group clean along San Fernando Road in the spring.
- CPAB: Ms. Sower: CPAB didn't meet in December, but will meet this Thursday
- VANC: Mr. O'Gara: Discussing NC subdivisions such as the "Glencrest" neighborhood subdivision and possible Neighborhood Council subdivision. Mr. Barry Stone of DONE commented that this process has not existed so there were no rules or policies governing it. A policy was approved about four months ago by BONC. Also discussed was the marijuana initiative its implemention.
- LANCC: Mr. O'Gara: Attended with Mr. Aggas. Six mayoral candidates spoke. Five didn't know much about the city when asked questions about homeless and planning issues, etc.
- Planning: No change on Starbucks application; Still planning a four story homeless shelter on Ratner St. where the recycling place used to be.
- Plancheck: Mr. O'Gara won't be able to attend due to a conflict with the Clean Streets ceremony
- Public Affairs: Ms. Sower announced the deadline for pothole-filling for 01/15/17 and discussed the upcoming Hearts for First Responders project now planned for Valentine's Day, 2017.
- Homeless: Ms. Vacas: Covered in Outreach above.
- Budget Advocates: Ms. Thum: Followup from December: Survey was emailed out asking for

- input on where money should be distributed.
- Finance: Looking for a Treasurer since Mr. Inkelaar-Cruz had to resign due to time commitments
- Clean Streets Challenge: Mr. O'Gara announced the upcoming recognition SVANC will receive at a ceremony at City Hall and determine what our reward will be. We need another cleanup because the corridor is a mess again. We need to work with the Dept. of Sanitation. Ms. Thum noted that we would not have known about the ceremony except that it was published in EmpowerLA's newsletter. Mr. Stone of DONE said that some in the department feel it's best to communicate with NC's via social media, email, or online.

ITEM 22: Discussion of Sun Valley Planning Projects in Particular the Community Plan for Sun Valley and the General Plan for the City

- Mr. O'Gara: The community plan and general plan are being discussed for revision. This includes
  upzoning and downzoning. This can affect areas in our area and nearby such as the Vulcan pit
  at Glenoaks and Peoria that is being filled with dirt, rocks and cement, and since it's being
  compressed, it will be ready for construction in just a few years.
- Waste Management had permission to build a huge trash recycling facility on Tujunga. It was
  designed to be state of the art, but due to difficulties including lawsuits it was never built. The
  court cases were settled last year. They will likely build the facility to accommodate the
  apartment/commercial waste franchise. When the facility is built it may be even better than the
  2010 design because of advancements in technology. This facility will add 1800 truck trips per
  day to the area, but will also provide area jobs. Ms. Perez commented that she, Mike and other
  members of the board at the time spent more than three years of frequent 4-hour evening
  meeting regarding the facility.
