SLO Vasquez directed resources to Sunland Park to have extra patrols to stop graffiti and get the tagging cleaned up. HOPE Team cleaned up homeless area near FedEx on Old San Fernando Road. MC 85.02 dwelling in a vehicle, enforcement will start next week in the red zones. People can only live in the green zones in your car. Must obey all posted signs and 72 hour parking. Stolen 1990's cars are on the rise. SLO distributed homeless resource pamphlets. Also thanked the Board for the treats and cards from the local schools.
