ITEM 6: Emergency Personnel from Fire and Police Departments

• Senior Lead Officers Vasquez and Wall had attended last meeting. Foothill Division has the lowest crime stats out of all the divisions although property crimes are up. Remember to lock your doors and windows as we approach the summer months. Caltrans has cleaned the 5 freeway at the Tuxford and Penrose exits. The homeless have been moving around and the HOPE team has been working on it. Summer Night Lights starts June 28th and ends August 25th with dedicated officers working the program. Services will be available Wednesday-Friday. Breaking Barriers Basketball will start this Saturday where officers play against citizens at All Nations Church 1000 Foothill 11:00AM-3:00PM. Food will be provided. Fun Run/Walk will be held July 22nd hosted by LAPD Foothill Division and the Cadets. LAPD now has to make appointments to have abandoned RVs removed from the streets if the RVs are 10,000# or more. The appointments take about three weeks from the time to schedule to have the RV removed.

ITEM 7: Announcements from elected officials or their representatives

- Field Deputy Jaqueline Serrano, Congressmember Cardenas, has just been assigned to SVANC and has been working for the Congressmember's office for three years. The office is here to assist with any issues with the Federal Government or their agencies. There are plans to have a mobile office July 21, 2017, 2:00PM-4:00PM at the Sun Valley library for people who cannot make it to the Panorama City office. Congress is in session and the Congressmember will be in the district next Friday. His current bills are focused on STEM and sex trafficking.
- Field Deputy Caesar Huerta, Councilmember Nury Martinez, has secured additional funding to help stop human sex trafficking by arresting the johns and pimps. The office has been working on getting the fair share of street resurfacing, trees, and sidewalks to the Sun Valley area as it has been neglected for so many years. Sidewalk repair program from the council office is coming to Sun Valley. This is a separate program from the City's \$30M sidewalk program. For more information on the City's sidewalk program go to www.safesidewalks.com. Seven trees have been removed on Sheldon due to disease. Sun Valley Rec Center has a new director, Jason Shepherd. Lights have been installed in the sixth neighborhood through a grant. The cost is about \$5000 per household.

 that is on Edmore Place and the developer wants to combine two properties into on. Speculation
 on what the eventual project will be. HHH funded 96 unit apartments will be built on Sheldon
 near the freeway for Veterans.

- Extensive discussion was heard from SVANC boardmembers including Mr. O'Gara, Ms. Vacas, Ms. Thum, Ms. Perez, Mr. Khalaf, Ms. Sower, and Mr. Koenig, covering subjects including: how felons would be dealt with, the definition or lack thereof of a Sanctuary City, if arrests have occurred specifically within Sun Valley, concern that certain points in the letter are vague and should be made more specific, the effect of deportations on schoolchildren of the community, who wrote the proposed letter, whether the letter is identical to what the other three or so NC's have already approved, what organizations are backing this letter and whether the board is aligned with their overall agenda and goals since we will be joined with them, concern that boardmembers should become more knowledgeable on the issues presented tonight to move

- forward with a vote, where further education on this issue can be obtained, and how the City itself is moving forward on the Sanctuary City issue.
- Ms. Thum motioned to amend this item to send it to a SVANC ad hoc committee/task force to address the complexities of the issues and to come to a consensus about what the board wishes to represent, and amend the letter to our particular neighborhood purposes and bring it back to the full board for consideration within two months. This was seconded by Ms. Vacas.
- Mr. Barry Stone, NEA of Dept. of Neighborhood Empowerment, offered Ms. Dueñas the choice of accepting the proposed amendment before moving forward with a vote
- Ms. Dueñas stated she did not accept the amendment; the amendment was discarded
- The original item was returned to the floor for a vote; the item failed 5/10
